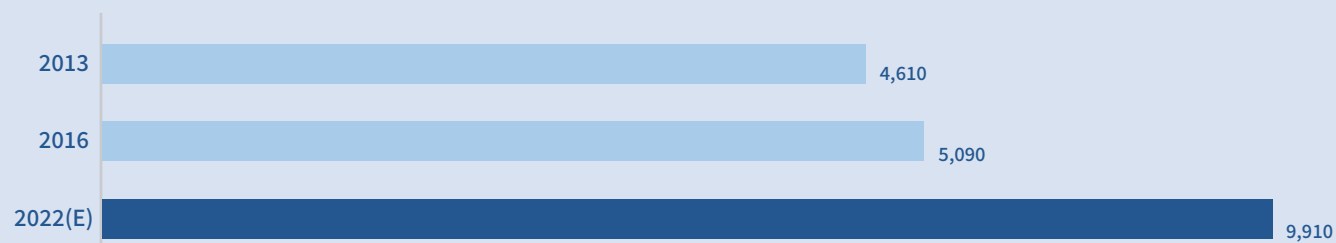
Increased damage due to illegal distribution

Trends in the size of trade in illegal copies (Unit: billion dollars)

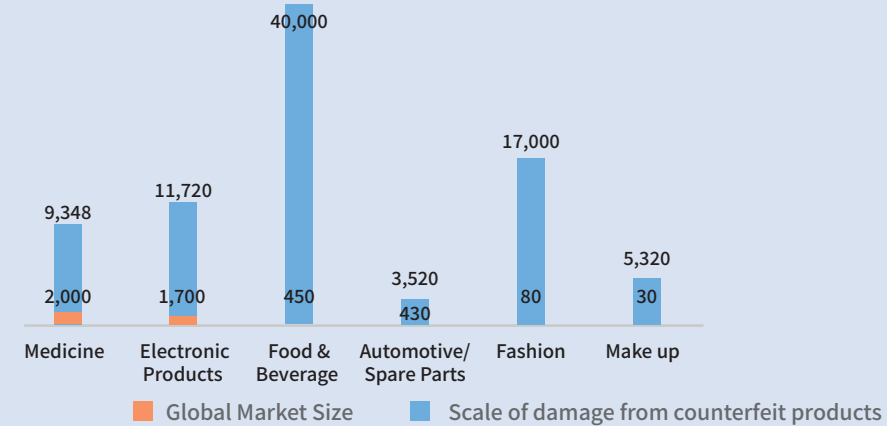

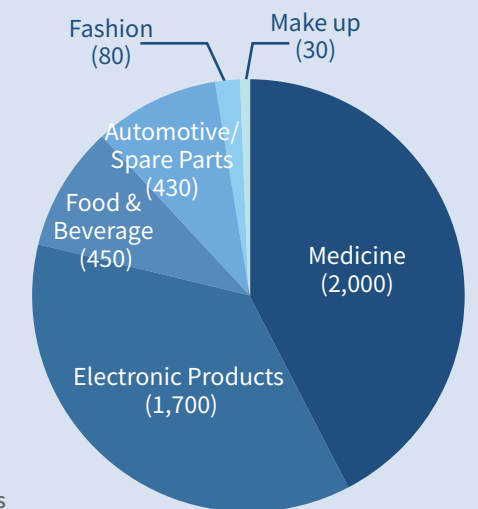

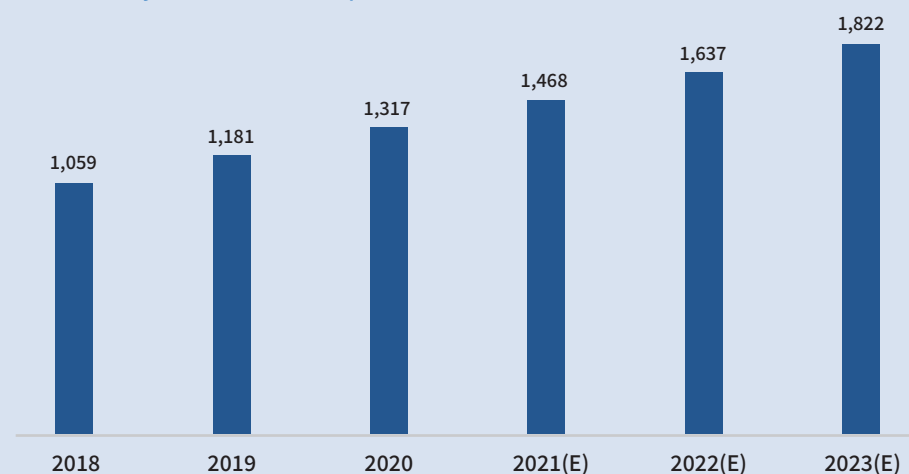

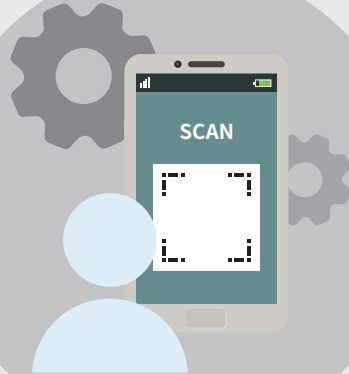

CASE 1 Recommended Company

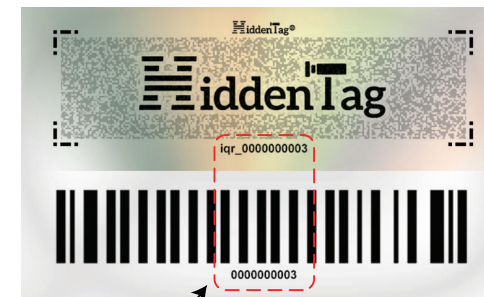
- Want to use more than one device to prevent label damage as much as possible.
- Want to quickly enter the necessary information for each product and easily edit it later.
- Switching is difficult because barcodes have been used previously or barcode use has been stabilized, but distribution tracking is necessary.

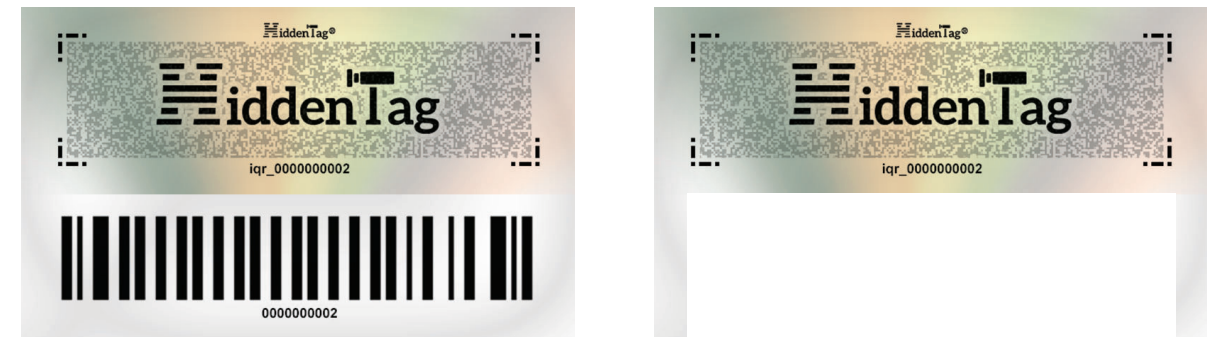

However, as we supply products at low prices with minimal margins, there are many restrictions and serial codes have been removed to ensure smooth supply, so please keep this in mind when purchasing. Thank you."

< Traceability in case of label damage >



- To prevent distribution tracking, in case of damaged barcode, the seller can be tracked using HiddenTag.
- Able to meet consumers' genuine needs
- Easy to arrest illegal sellers and manage goods

CASE 2.

Combination of “N” HiddenTag and barcode

CASE 2 Recommended Companies

- Companies that use barcode labels only on existing logistics packaging boxes
- The quantity of products in a box is fixed, and individual management is required by attaching HiddenTag to the products.
- Incoming and outgoing shipments are managed manually using Excel, but errors and management accuracy are lacking.
- Want to use the HiddenTag Light version.



- Produced by matching “N” HiddenTags and 1 EA barcode
- HiddenTag label quantity and form can be changed
- Can be provided in CSV file format suitable for barcode management

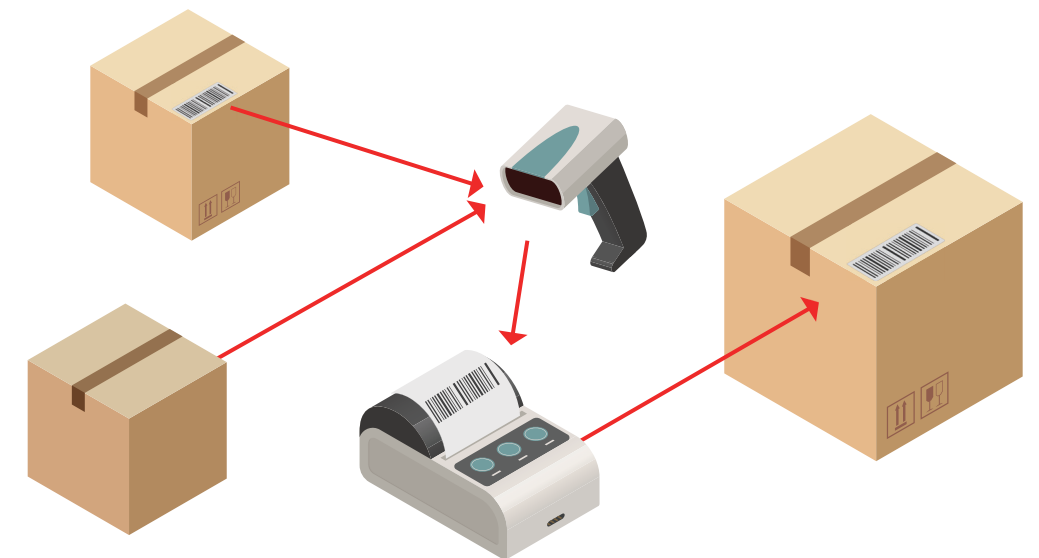

CASE 3.

Issuance of aggregation barcode according to packaging stage

CASE 3 Recommended Companies

- We have our own manufacturer, and line facilities such as existing barcode fixed scanners have been built and are in operation.
- After scanning a certain quantity of barcode labels, it is necessary to automatically issue bundled barcode labels
- Fast product arrival/delivery processing and quantity management are required.



① Scan barcode

- Scan the individual code attached to the product
- Scanned individual code information + certain quantity measurement

② Issuance of aggregation code

- Primary aggregation through scanned information
- Check the contents of the box through the corresponding barcode

③ Outbox/Set

- Scan codes on medium boxes containing individual products
- Generation and attachment of secondary aggregation code

Master label (representative code)

CASE 4 Recommended Companies

- Want to manage it easily with just my smartphone, without barcodes. (Cost reduction)
- Used an existing barcode, but want to manage it simply and easily using my smartphone.
- Want to manage quickly and efficiently through box-by-box scanning during stocking and shipping.

EX) M label designation for 20 HiddenTags



After designating the M label,
attach it to the out box.



<What is the M label?>

- Master label representing sub-products after section designation = M label
- By attaching it to an outbox and shipping it out, it is possible to quickly manage the arrival and departure of goods.
- Synchronize M label scan history with sub-labels (individual scan required)
- Manage receipts and shipments and check scan history information

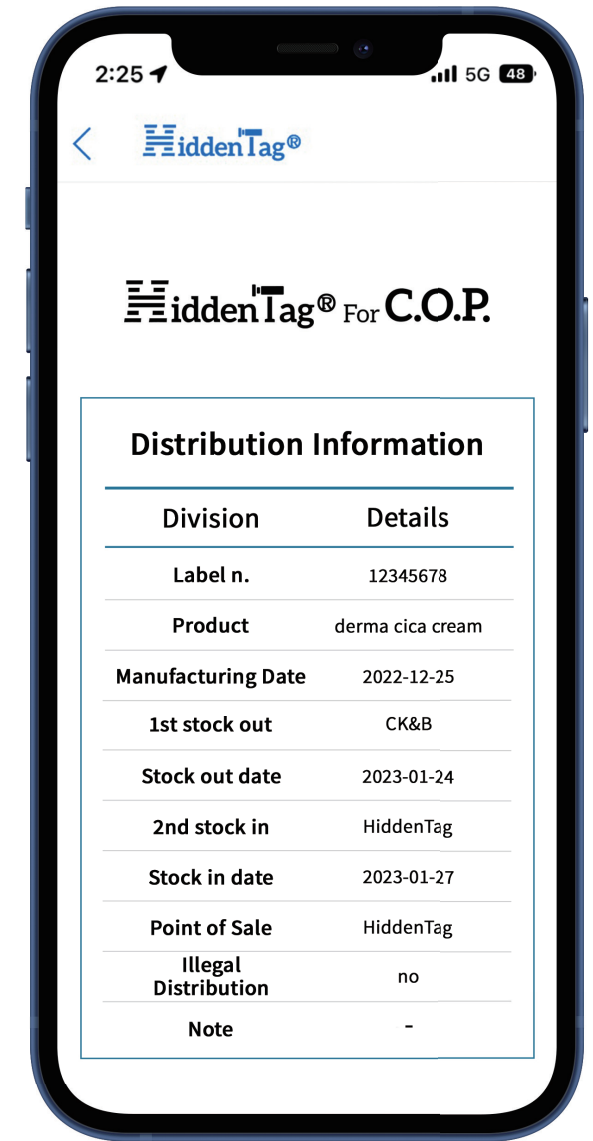

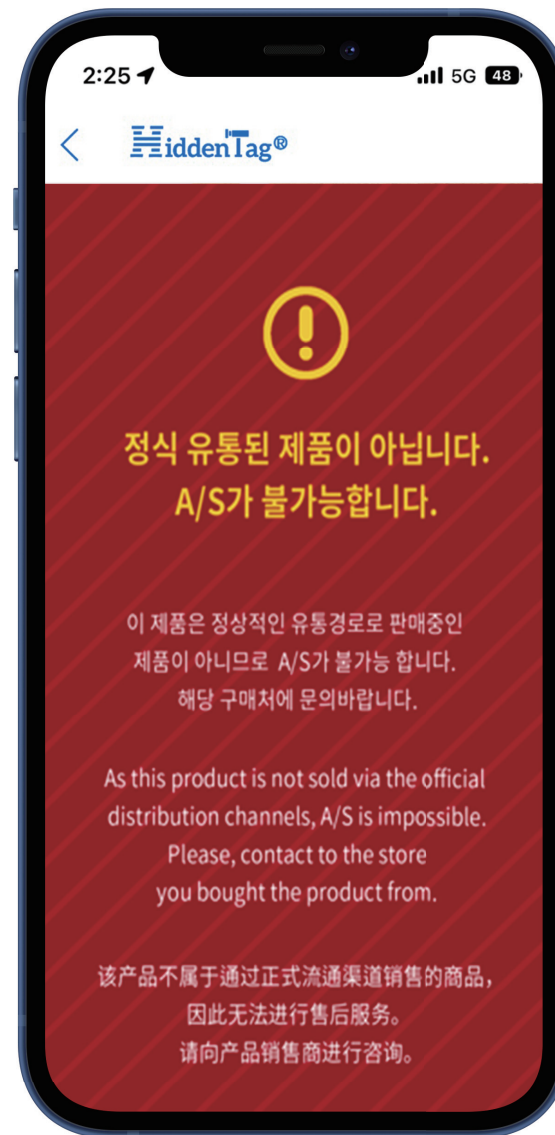

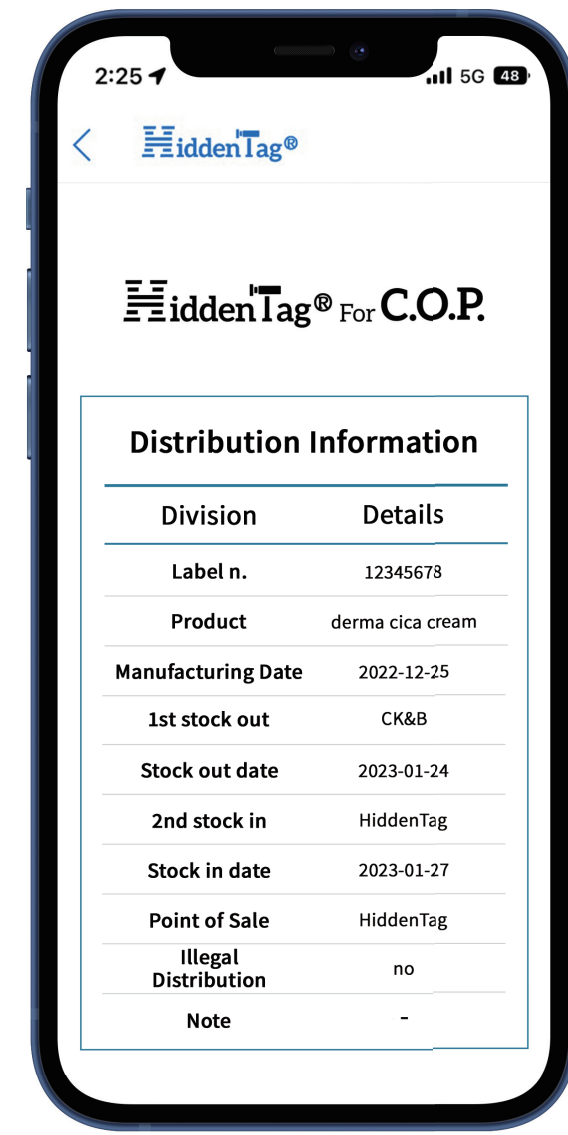

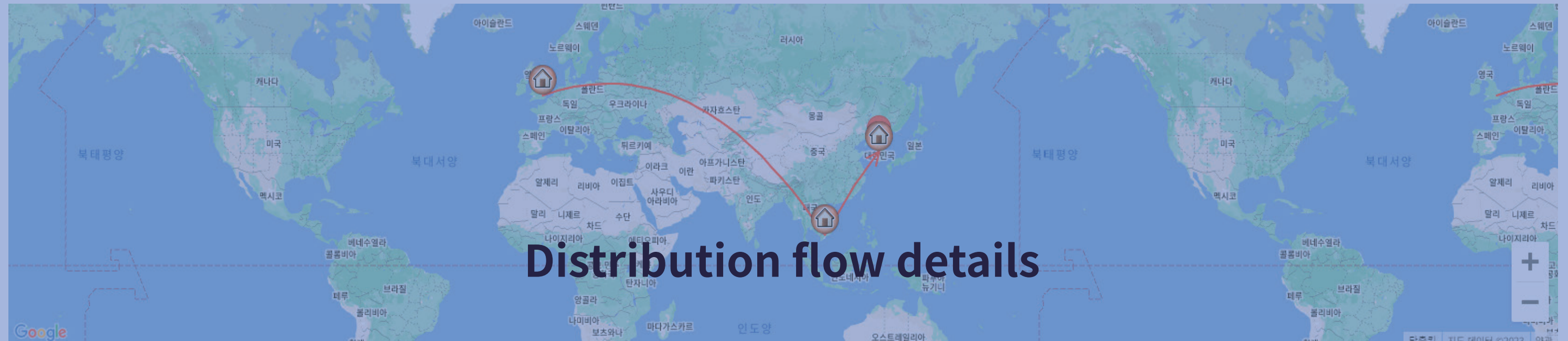

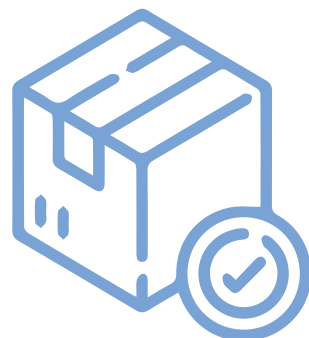
Check product feedback
